Our sending church, Tabernacle Baptist Church in Virginia Beach, Virginia, is completely behind this leading of the Lord in our lives. Since finding Christ as our Savior, my wife and I have attempted to honor the Lord in His service. I was called to the ministry in 1983 while living in New York City under the leadership of Pastor Doug Lowery. We moved to Virginia Beach in 1985 where I attended Tabernacle Baptist Bible College & Seminary for nine years and graduated in 2004 with a Masters of Religious Education degree.
